### ITEMS FOR DISCUSSION:

a. Preliminary Budget 2015

The board reviewed the proposed budget for 2015. During the discussion, the board decided to increase the line item amount for the board attorney from \$3,000.00 to \$3,500.00. Ms. Glashoff stated that she didn't have an amount in for litigation and said she wanted to leave it up to the board to decide on an amount.
