**AN ORDINANCE REVISING CHAPTER 205, ARTICLE II
OF THE TOWNSHIP OF LEBANON,
COUNTY OF HUNTERDON, STATE OF NEW JERSEY**

WHEREAS, the Township of Lebanon is desirous to update and revise its Municipal Code pertaining to Chapter 205, Fees, Article II, 4 - Fee Schedule

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Lebanon, in the County of Hunterdon, that the Municipal Code of the Township of Lebanon pertaining to Chapter 205, Fees, Article II, Fee Schedule, is hereby revised and supplemented as follows (additions indicated in boldface and italics *thus*; deletions indicated with strike-through ~~thus~~):
