RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF LEBANON, IN THE COUNTY OF HUNTERDON, NEW JERSEY, COVENANTING TO COMPLY WITH THE PROVISIONS OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED, APPLICABLE TO THE EXCLUSION FROM GROSS INCOME FOR FEDERAL INCOME TAX PURPOSES OF INTEREST ON OBLIGATIONS ISSUED BY THE TOWNSHIP OF LEBANON AND AUTHORIZING THE MAYOR, TOWNSHIP CLERK, CHIEF FINANCIAL OFFICER AND OTHER TOWNSHIP OFFICIALS TO TAKE SUCH ACTION AS THEY MAY DEEM NECESSARY OR ADVISABLE TO EFFECT SUCH COMPLIANCE AND DESIGNATING A \$972,292 BOND ANTICIPATION NOTE, DATED JULY 23, 2021, PAYABLE JULY 22, 2022, AS A "QUALIFIED TAX-EXEMPT OBLIGATION" PURSUANT TO SECTION 265(b)(3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED.

WHEREAS, the Township of Lebanon, in the County of Hunterdon, New Jersey (the "Township") from time to time issues bonds, notes and other obligations the interest on which is excluded from gross income for Federal income tax purposes and desires to take such action as may be necessary or advisable to establish and maintain such exclusion; and

WHEREAS, the Internal Revenue Code of 1986, as amended (the "Code"), contains provisions with respect to the exclusion from gross income for Federal income tax purposes of interest on obligations, including provisions, among others, which require issuers of tax-exempt obligations, such as the Township to account for and rebate certain arbitrage earnings to the United States Treasury and to take other action to establish and maintain such Federal tax exclusion; and

WHEREAS, the Township intends to issue a \$972,292 bond anticipation note, dated July 23, 2021 and payable July 22, 2022 (the "Note"); and

WHEREAS, the Township desires to designate the Note as a "qualified tax-exempt obligation" pursuant to Section 265(b)(3) of the Code;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Lebanon, in the County of Hunterdon, New Jersey, as follows:

<u>SECTION 1</u>. The Township Committee hereby covenants on behalf of the Township, to the extent permitted by the Constitution and the laws of the State of New Jersey, to do and perform all acts and things permitted by law and necessary to assure that interest paid on bonds, notes or other obligations of the Township (including the Note) be and remain excluded from gross income of the owners thereof for Federal income tax purposes pursuant to Section 103 of the Code.

<u>SECTION 2</u>. The Mayor, Township Clerk, Chief Financial Officer and other officials of the Township are hereby authorized and directed to take such action, make such representations and give such assurances as they may deem necessary or advisable to effect compliance with the Code.

<u>SECTION 3</u>. The Note is hereby designated as a "qualified tax-exempt obligation" for the purpose of Section 265(b)(3) of the Code.

<u>SECTION 4</u>. It is hereby determined and stated that (1) the Note is not a "private activity bond" as defined in the Code and (2) the Township and its subordinate entities, if any, do not reasonably anticipate issuing in excess of \$10 million of new money tax-exempt obligations (other than private activity bonds) during the calendar year 2021.

<u>SECTION 5</u>. It is further determined and stated that the Township has not, as of the date hereof, issued any tax-exempt obligations (other than the Note) during the calendar year 2021.

<u>SECTION 6</u>. The Township will, to the best of its ability, attempt to comply with respect to the limitations on issuance of tax-exempt obligations pursuant to Section 265(b)(3) of the Code; however, said Township does not covenant to do so, and hereby expressly states that a covenant is not made hereby.

<u>SECTION 7</u>. The issuing officers of the Township are hereby authorized to deliver a certified copy of this resolution to the original purchaser of the Note and to further provide such original purchaser with a certificate of obligations issued during the calendar year 2021 dated as of the date of delivery of the Note.

<u>SECTION 8</u>. This resolution shall take effect immediately upon its adoption. The foregoing resolution was adopted by the following roll call vote:

WHEREAS, the printing and mailing of the 2021 property tax bills was setback due to the delay in the certification of the annual tax rate by the Department of Community Affairs and the Hunterdon County Tax Board;

WHEREAS, the 2021 tax bills will be printed and mailed to the property owners of the Township of Lebanon prior to 8/2/2021; and

WHEREAS, NJSA 54:4-66.3(d) provides that the current years taxes shall not be subject to interest until the twenty-fifth day after the tax bill for the third installment is mailed and NJSA 54:4-64 further provides that the property taxpayers shall be given adequate notice of the date when taxes are due before interest is charged on delinquent tax payments.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Township of Lebanon, County of Hunterdon, State of New Jersey that in accordance with State Law, the grace period for the August 2021 property tax bill is extended to August 27, 2021, after which time said payments will be delinquent and subject to interest penalties calculated from August 1, 2021, and

BE IT FURTHER RESOLVED that interest will be charged on all tax payments received after August 27, 2021

OLD BUSINESS

DPW Loader

Mr. Barberio stated that he received a 069-G State Grant Agreement between the NJDEP and the Township. He has obtained most the required signatures. Once completed he will be forwarding to the DEP Representative for final approval. The grant amount is \$55026.44 which will assist in the purchase of the DPW Loader.

Motion by Mr. McKee, seconded by Mr. Abuchowski and carried by unanimous favorable roll call vote, the Township Committee authorized the issuance of a Purchase Order for a 2021 John Deere 544 P, 4WD Loader, in the amount of \$183,421.47, to Jesco of South Plainfield, under State CO-OP # 65MCESCCPS. Funds are in the Capital Ordinance.

Cannabis Ordinance

Ms. Koehler suggested that the Committee hold open August 19th and August 20th as possible dates to have an emergency meeting should there be a reason to cancel the August 18, 2021 meeting. This is a precautionary measure to ensure that the Committee will be able to hold the Public Hearing on the Cannabis Ordinance prior to the August 21, 2021 deadline.

Motion by Mr. Abuchowski, seconded by Ms. Koehler and carried by unanimous favorable roll call vote, the Township Committee approved the Shared Services Agreement with the NHVRHS for a School Resource Officer and authorized the Mayor to sign.

Police Department Sign

Mr. Laul stated that there is a man in town who does signs. He provided the Committee with a few drawings to replace the Police Department sign.

The cost is \$1000 and Mr. Laul has offered to paint the sign.

Motion by Mr. Laul, seconded by Ms. Koehler and carried by unanimous favorable roll call vote, the Township Committee approved the purchase of the sign for \$1000 from Brandon Holmes, With the Grain, and for Mr. Laul to paint.

Mayor Schmidt stated that the sign in front of the Municipal Office has been replaced. It was arranged by Past Committeeman Wunder and created and donated by Chamberlain Signs & Graphics. The Committee thanked them for their contribution to the Township.

Police Chief's Request to Purchase 2 Ballistic Vests

Historian Laurie Hoffman – Request for Memorial Bench

Mr. McKee stated that the Historians had a unanimous vote to purchase a memorial bench in honor of George Zak who recently passed away. The bench is to be placed at the Museum.

Ms. Laurie Hoffman requested approval from the Committee to spend up to \$1500.00 from the Historian's Trust Account. They would like to purchase a bench as George Zak was an honorary member of the Historian Committee.

The Committee discussed whether the Trust Account money is public funds and if it is acceptable to pay for the bench through it. Discussion was held on where to place the bench at the museum.

The Committee agreed that there needs to be a policy on how to handle such a request. The useful life of the bench has to be considered. A memorial can be for the life of the bench or a set period of time.

It was decided that there is a need to set up a subcommittee to establish policy for memorials. The subcommittee will work with the Park Committee as there are many memorial benches in the Park.

Motion by Mr. Abuchowski, seconded by Mr. McKee and carried by unanimous favorable roll call vote, the Township Committee approved Ms. Koehler and Mr. Laul as a sub-committee to conduct research and develop policy for memorials in all public locations in the Township.
