Sign Ordinance

The Committee decided that it would be wise to receive input from the Planning Board on the ordinance prior to the introduction. The ordinance should be finalized by the Committee prior to the Board's December 4, 2021 meeting.

A new draft ordinance has been provided to the Committee. Mr. Abuchowski said that he spoke with the Police Chief, the Engineer and the Zoning Officer and the line of site has not been an issue in the past. There have been no incidents or motor vehicle accidents recalled. Mr. Abuchowski said that a line of site does not have a clear definition as it is based on the speed limit and the typography of the road. Mr. Abuchowski advised that it is best to be silent on the line of site as additional ordinances may need to be adopted.

Mayor Schmidt said that he would like to walk the Library corner to establish a reasonable distance for the signs to be placed. The ordinance will be finalized at next meeting to be sent to the Planning Board.

Police Chief's Request to Purchase – 2022 Police Interceptor Utility All Wheel Drive Base Vehicle

Motion by Mr. Abuchowski, seconded by Mr. Laul and carried by unanimous favorable roll call vote, the Township Committee approved the purchase of a 2022 Police Utility All Wheel Drive Base Vehicle from Winner Ford, State Contract # 20-Fleet-01189, in the amount of \$31,141.00.

Police Vehicle Equipment and Detailing

Motion by Mr. Laul, seconded by Ms. Koehler and carried by unanimous favorable roll call vote, the Township Committee approved the purchase of equipment for the 2022 Police Vehicle from General Sales Administration T/A Major Police Supply, State Contract # 17 FLEET-00760, in the amount of \$13,842.47.

Fire Chief's Request to Purchase Equipment

Motion by Mr. Laul, seconded by Mr. McKee and carried by unanimous favorable roll call vote, the Township Committee approved the purchase of a Fast Rescue Board in the amount of \$2285.00 from Fast Rescue Solutions.

Motion by Mr. Laul, seconded by Mr. McKee and carried by unanimous favorable roll call vote, the Township Committee approved the purchase of Rite Pak Fast Attack Hose at \$2464.20 and Blitz Fire Inlet and Outlet Stack Tips and Storage Backet in the amount of \$2642.00 from NJ Fire Equipment.

RESOLUTION AUTHORIZING EXECUTIVE SESSION


