Memorial Policy

Mr. Laul stated that the proposed Memorial Policy was provided to the Park Committee for their review and comments as they are the primary group that deals with memorials. Mr. Laul noted that annually or biannually the Park Committee can prepare a list of donations that would fit their need in the park. Donations will come to the Township with a request form. Mr. Laul said that the need for maintenance during the life of the memorial will need to be considered as well as an end-of-life policy. Mr. Laul said that once the Committee approves the Memorial Policy, they will need to consider other municipal properties to see if memorials will or will not be permitted.

Ms. Koehler said that she and Mr. Laul met with the Park Committee twice to discuss the Policy. Ms. Koehler said that she took back the comments of the Park Committee and researched around the Country to pick things that seemed to best fit the Township. Ms. Koehler noted that they did get the blessing from the Park Committee.

Discussion held.

Ms. Koehler and Mr. Laul asked for the Committee to review the policy to provide remarks at a later meeting. Attorney Lyons advised that the Policy will need to be adopted through an ordinance.

PERSONNEL POLICY AND PROCEDURE MANUAL

Mayor Schmidt stated that the Committee received the newest draft of the Personnel Policy and Procedure Manual this morning. It will likely be placed on the next meeting agenda for discussion.

NEW BUSINESS

EOSC – Naming of Preserved Properties

Attorney Lyons noted that naming the properties will have to be done though an ordinance.

Mr. Adam Duckworth, Chairman of the Environmental and Open Space Committee stated that the EOSC is proposing to name five parcels of preserved land in the Township. The parcels are all solely owned by the Township. The proposal is to name three lots as one as they adjoin each other. The other two lots will be named individually. Mr. Duckworth stated that the proposal represents parcels that the Township has some ownership stake that they would like to advertise more. There may be trails placed on the property and they are already a part of the hunting program. EOSC had discussions on the names, they received some historical input and spoke with a few of the local residents in the Bunnvale area. The EOSC have agreed on names for two of the properties and is asking for Committee input on the last.
