Comments and recommendations were received from Mr. Richard Webb, Mr. Bill Bohn and Mr. Mike Iannace regarding the draft ordinance.

Ms. Sharon Petzinger commented on hydroponics farming.

*Motion by Mr. McKee, seconded by Ms. Koehler and carried by unanimous favorable roll call vote, the* Township Committee amended the ordinance to add an 8<sup>th</sup> WHEREAS clause: WHEREAS, the Township Committee of the Township of Lebanon has determined that the presence of ATCs and other medicinal cannabis establishments in the Township would be inconsistent with the efforts in the Township's public and private schools to promote respect for the law and discourage substance abuse and necessary and appropriate and in the best interests of the health, safety and welfare of the Township's residents; and

Motion by Mr. Laul, seconded by Ms. Koehler and carried by unanimous favorable roll call vote, the Township Committee amended the ordinance to add a 9<sup>th</sup> WHEREAS clause: WHEREAS, the Township Committee of the Township of Lebanon has determined that ATCs and other medicinal cannabis establishments present similar zoning concerns as those cannabis establishments regulated by Ordinance No. 2021-07, and should be regulated consistently in order to implement a rational zoning plan; and

Comments were received from the public regarding value judgements with regard to establishments, ordinance must include every possible process in manufacturing, concerns with paraphernalia being displayed in the local stores, requests to not ban hydroponics.

The Committee was thanked for including the public and private schools in the ordinance, for giving the parents the ability to speak to their children about marijuana, not the government, concerns with the possibility of cannabis being given away in exchange for the purchase of another item.

Concerns were raised about signs or billboards that relate to drug use and cannabis. The Committee will consider placing language in the sign ordinance relating to such.
