RESOLUTIONS

NO. 01-2024 RESOLUTION SETTING THE ANNUAL MEETING SCHEDULE FOR TOWNSHIP BOARD OF HEALTH MEETINGS FOR CALENDAR YEAR 2024

WHEREAS the Open Public Meetings Act (Ch 231, P.L. 1975) provides for the giving of annual notice by public bodies of the time, date and location of the regular meetings of such public body to be held during the succeeding year, and

WHEREAS the Open Public Meetings Act (Ch 231, P.L. 1975) hereinafter referred to as the Act, authorizes a public body to make certain other determinations and take certain other actions in conformance therewith:

NOW, THEREFORE, BE IT RESOLVED by the Township Board of Health of Lebanon, County of Hunterdon and State of New Jersey as follows:

Regular meetings of this Board shall be held during the 2024 calendar year at 6:30 p.m. at the Lebanon Township Municipal Building, 530 West Hill Road, Glen Gardner,

(Lebanon Township) New Jersey, on the first Wednesday of each month, as needed. The following newspapers are hereby designated as the newspapers to receive any and all notice required or permitted to be given under the Act including but not limited to this Annual Notice and 48 hour notices:

- a. The Hunterdon Review which is the official newspaper of this public body and
- b. The Hunterdon County Democrat, Express Times and Star Ledger which are hereby determined to be the other newspapers which have the greatest likelihood of informing the public within the area of jurisdiction of this Township of its meetings.

Copies of the Resolution and any revisions or modifications thereof, certified to be true copies by the Board Secretary of this municipality, be disseminated and distributed as required by the Act as follows:

- a. Posted and maintained throughout the 2024 calendar year on the bulletin board at the Lebanon Township Municipal Building;
- b. Emailed to the newspapers designated in paragraph 2 of this Resolution;
- c. Filed with the Clerk of this Municipality, and
- d. Mailed, faxed or emailed to such other persons as may be entitled thereto under the terms of the Act and this Resolution.

The Board Secretary of the Municipality is hereby authorized and directed to mail such notice as may be required and authorized to any person requesting the same providing that person has first complied with the following terms and conditions:

- e. Any and all requests for notice shall be made in writing either by letter or by signing a Request List to be maintained in the Board of Health office; and
- b. Any person requesting such notice, other than the news media which expressly excluded from payment of any fee hereunder, shall pay to the Township of Lebanon a fee in the amount of which is calculated solely to reimburse this Township for the costs incurred in providing the said notice; including, but not limited to photocopying costs and postage.

NEW BUSINESS

Septic System Alteration Waiver 227 Musconetcong River Road Block 60, Lot 19

The following waivers will need to be acted on by the Board:

- 1. The proposed disposal field is not the minimum 25 feet to the existing dwelling. The proposed disposal field is shown 23 feet from the existing dwelling.
- 2. The toe of the slope is not the counties policy of a minimum 10 feet from the property line. The toe of the slope is shown 6 feet from the property.

The Board will need to act or acknowledge the following as a condition of making the application to the DEP.

1. A sewage ejector pump is being proposed for a single basement bathroom, the pump discharges to the gravity piping within the interior of the dwelling and the pumping volume per cycle is small, a waiver for the disposal area size not being overdesigned by 50 percent is being requested, a TWA permit will need to be obtained from the DEP.

Mr. Kurt Hoffman, P.E. provided details on the system and requested waivers and TWA Permit.

Mr. Wojcik asked for a motion to approve the 2 waivers and permission for the applicant to submit a TWA Permit application to the State of New Jersey.
