Said improvements and acquisitions shall include all equipment, work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$640,000.00 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the 2023 Capital Improvement Fund of the Township. The sum of \$640,000.00 is hereby appropriated from the 2023 Capital Improvement Fund of the Township to the payment of the cost of said purpose.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and

acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

NO. 148-2024 RESOLUTION SUPPORTING SCR-81/ACR-58 AIMED AT INCREASING THE NEW JERSEY VETERANS' PROPERTY TAX DEDUCTION TO \$2,500

WHEREAS, The Veterans property tax deduction, currently set at \$250.00, has not been increased in over twenty years; and

WHEREAS, bipartisan bills SCR-81/ACR-58 propose a constitutional amendment to increase the amount of veterans' property tax deduction from \$250.00 to \$2,500.00 over four years; and

WHEREAS, under the State Constitution both houses of the state legislature must approve the bills either by supermajority votes or in consecutive years; and

WHEREAS, according to the legislation, Veterans who are honorably discharged from active service in a branch of the United States Armed Forces qualify for the deduction. A qualified

veteran's surviving spouse would receive the deduction after the qualified veteran dies; and

WHEREAS, the legislation calls for the proposed increase in the property tax deduction to be phased in over a four-year period and the state would provide municipalities with funding to offset the tax revenue reduction; and

WHEREAS, it is the opinion of the Township Committee of the Township of Lebanon that Veterans, deserve this recognition that has been earned through their sacrifice and dedicated service to the Nation.

Matters involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance, promotion or disciplining of any specific prospective or current public officer or employee of the public body, where all individual employees or appointees whose rights could be adversely affected have not requested in writing that the matter(s) be discussed at a public meeting; the employee(s) and/or general nature of discussion is: CFO position, Finance Department. And whereas the public disclosure of such information at this time would violate the employee(s) privacy rights; therefore, this information will be withheld until such time as the matter is concluded or the threat to privacy rights no longer exists;

Deliberation occurring after a public hearing that may result in the imposition of a specific civil penalty or loss of a license or permit.

BE IT FURTHER RESOLVED that the Mayor and Committee hereby declare that their discussion of the subject(s) identified above may be made public at a time when the Township

Attorney advises them that the disclosure of the discussion will not detrimentally affect any right, interest or duty of the Township or any other entity with respect to said discussion.
