ORDINANCE FOR INTRODUCTION

Ms. Koehler asked to reorder the Agenda, moving Ordinance No. 17-2024 up to discuss.

NO. 17-2024 ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF LEBANON AND GRANTING TO THE PLANNING BOARD OF THE TOWNSHIP OF LEBANON THE POWERS FORMERLY HELD BY THE LEBANON TOWNSHIP ZONING BOARD OF ADJUSTMENT

WHEREAS, the Municipal Land Use Law, <u>N.J.S.A.</u> 40:55D-25 c. (1), specifically allows municipalities having a population of 15,000 or less, if provided by ordinance, to grant to a ninemember Planning Board, to the same extent and subject to the same restrictions, all the powers of a board of adjustment operating within such a municipality, except that the Class I and Class III members are not permitted to participate in the consideration of applications for development which involve relief pursuant to section d. of section 57 of P.L. 1975, c.291 (N.J.S.A. 40:55D-70:; and

WHEREAS, the Township of Lebanon has a population of 15,000 or less; and

WHEREAS, it is the desire of the Township Committee of Lebanon Township to reduce tax burdens on the township taxpayers by eliminating the dual expenses of having both a planning board and board of adjustment; and

WHEREAS, it is further the desire of the Lebanon Township Committee to consolidate zoning matters into one body so that uniform and consistent zoning in accordance with the Municipal Land Use Law would be advanced within the Township; and

WHEREAS, when the Planning Board exercises the powers of the former Lebanon Township Zoning Board of Adjustment, any Class I and Class III member of said Planning Board shall not participate in the consideration of any applications for development which involve relief pursuant to subsection (d) of <u>N.J.S.A.</u> 40:55D-70; and

WHEREAS, any matters pending before the Township Zoning Board of Adjustment prior to February 1, 2025, and the adoption of this ordinance shall be heard in accordance with <u>N.J.S.A.</u> 40:55D-72.1; and

WHEREAS, the Lebanon Township Municipal Code will require amendment to incorporate the changes as contemplated by this Ordinance.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Lebanon, County of Hunterdon, and State of New Jersey as follows:

SECTION 1. As of January 1, 2025, the Zoning Board of Adjustment of the Township of Lebanon is hereby abolished, except that any applications then pending before said Zoning Board of Adjustment will continue to be heard in accordance with <u>N.J.S.A.</u> 40:55D-72.1.

SECTION 2. The purpose of this Ordinance is to grant the powers of the former Zoning Board of Adjustment to the Municipal Planning Board. To that extent, this Ordinance may not be all inclusive so that if there is any section of the Code of Lebanon Township, or ordinance, whether the same be a Municipal Land Use Ordinance or otherwise, which grants powers to the Municipal Zoning Board of Adjustment, said powers shall now lie with the Planning Board.

SECTION 3. Any Class I and Class III member of the Planning Board shall not participate in the consideration of any applications of development which involve relief pursuant to subsection (d) of <u>N.J.S.A.</u> 40:55D-70.

SECTION 4. Amendment of Chapter 45 of the Code of the Township of Lebanon entitled "Land Use Procedures": All sections and references to the Zoning Board of Adjustment shall be deleted to the extent that any provisions thereof may now be redundant, and any powers, criteria and jurisdiction contained therein shall now lie with the Municipal Planning Board.

SECTION 5. Chapter 45, §45-24 of the Lebanon Township Municipal Code entitled "Membership" is hereby amended, pursuant to <u>N.J.S.A.</u> 40:55D-23.1 to provide for four alternate members. The revisions to this section are as follows (deletions have strikethrough; changes in **boldface** and underlined):

§45-24 Membership.

- A. The Planning Board shall consist of nine regular members and up to two <u>four</u> alternate members, all of whom, except for the Class II members set forth below, shall be municipal residents. For purposes of appointment, the membership shall be divided and appointed as per the following classes:
 - (1) Class I: the Mayor or the Mayor's designee in the absence of the Mayor.
 - (2) Class II: one of the officials of the municipality other than a member of the governing body, to be appointed by the Mayor; provided that, if there be an Environmental Commission, the member of the Environmental Commission who is also a member of the Planning Board as required by § 1 of P.L. 1968, c. 245 (N.J.S.A. 40:56A-1), shall be deemed to be the Class II Planning Board member for purposes of this article in the event that there be among the Class IV or alternate members of the Planning Board both a member of the Zoning Board of Adjustment and a member of the Board of

Education.

- (3) Class III: a member of the Township Committee to be appointed by it.
- (4) Class IV: other citizens of the municipality, to be appointed by the Mayor.
- B. No changes.
- C. Alternate members. The Mayor may appoint up to two four alternate members to the Planning Board in the same vein as Class IV members and shall be Township residents. The members shall be designated by the Mayor as "Alternate No. 1" and "Alternate No. 2" and so on. No alternate member shall be permitted to act on any matter in which he has either directly or indirectly any personal or financial interest. An alternate member may, after public hearing if he requests one, be removed by the governing body for cause. Alternate members may participate in all matters but may not vote except in the absence or disqualification of a regular member of any class. Participation of alternate members shall not be deemed to increase the size of the Planning Board established by ordinance of the governing body pursuant to § 14 of P.L. 1975, c. 291 (N.J.S.A. 40:55D-23). A vote shall not be delayed in order that a regular member may vote instead of an alternate member. In the event that a choice must be made as to which alternate member is to vote, Alternate No. 1 shall vote.

SECTION 6. When necessary for the purposes of implementing this ordinance and the election to have the Municipal Planning Board exercise, to the same extent and subject to the same restrictions, all the powers of a Zoning Board of Adjustment, the term "Planning Board" shall be substituted for the term "Zoning Board of Adjustment" or equivalent in each and every instance where "Zoning Board of Adjustment" or equivalent appears in any section of the Code of the Township of Lebanon, Township Ordinance, Resolution, rule, regulation or amendments thereto.

SECTION 7. Where the substitution of "Planning Board" for "Zoning Board of Adjustment" or equivalent results in an apparent duplication, redundancy, or conflict in any section of the Code of the Township of Lebanon, Township Ordinance, Resolution, rule or regulation, the same shall be liberally construed and interpreted in accordance with the intent and purpose of N.J.S.A. 55D-25 c. (1) as adopted herein, whereby the Municipal Planning Board replaces and to the same extent and subject to the same restrictions exercises all the powers of the Zoning Board of Adjustment.

SECTION 8. All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

SECTION 9. Should any sentence, clause, sentence, phrase or provision of this ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

SECTION 10. This ordinance shall take effect immediately upon adoption and publication according to law.

ORDINANCES FOR PUBLIC HEARING AND ADOPTION

NO. 15-2024 ORDINANCE AUTHORIZING VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE TOWNSHIP, APPROPRIATING THEREFOR THE SUM OF \$125,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE 2024 CAPITAL IMPROVEMENT FUND OF THE TOWNSHIP

BE IT ORDAINED by the Township Committee of the Township of Lebanon, County of Hunterdon, State of New Jersey, as follows:

Section 1. The Township of Lebanon, County of Hunterdon, State of New Jersey (the "Township") is hereby authorized to undertake the following public improvements and acquisitions in, by and for the Township: (A) undertaking of improvements in the Municipal

Building. Said improvements and acquisitions shall include all equipment, work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$125,000.00 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the 2024 Capital Improvement Fund of the Township. The sum of \$125,000.00 is hereby appropriated from the 2024 Capital Improvement Fund of the Township to the payment of the cost of said purpose.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Township having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefitted.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection.

Section 5. This Ordinance shall take effect at the time and in the manner provided by law.
